## **APPROVAL OF MINUTES**

Dustin Robinson moved, Travis Holcomb seconded, to approve as written the February 21, 2023 regular council meeting minutes. Sam Meers, yea. Dennis Smith, abstain. Darrell Lamme, abstain.

Travis Holcomb moved, Sam Meers seconded, to approve as written the April 3, 2023 regular council meeting minutes. Darrell Lamme, yea. Dustin Robinson and Dennis Smith, abstain.

## **VISITORS**

Riverside School art students gave a presentation to the governing body, requesting the governing body to sign a decree declaring the month of March be known as Youth Art Month. Travis Holcomb moved, Sam Meers seconded, to adopt/sign the decree declaring the month of March as Youth Art Month. Dennis Smith, Dustin Robinson and Darrell Lamme, yea.

Julie Bergman, Rainbow Telecommunications, appeared before the governing body to inform them of an upcoming expansion of their fiber network in Elwood. The expansion is to begin in 2025 and will offer fiber network to all Elwood residents. The project is a 3 million dollar investment.

## **CHIEF OF POLICE**

Chief Brandon Whetstine introduced new part time officer Dustin Winters.

#### CITY SUPERVISOR

The governing body reviewed a bid for trimming trees out of electrical lines from Asphund. The bid was in the amount of \$6848.89.

Wayne Hall told the governing body lift station number 8 had a hole in the pipe and needed repaired. The repairs are currently being made.

Dennis Smith moved, Dustin Robinson seconded, to accept the bid from Asphund in the amount of \$6848.89 to trim trees out of the electrical lines. Sam Meers asked if any local bids were received. Sam Meers voted no. Travis Holcomb and Darrell Lamme voted no, with Holcomb saying he wanted another bid.
